Operation School Bell provides back to school essentials including new school clothing, underwear, socks, shoes, jackets, and backpacks to elementary school children in the Whittier area who are identified by their schools as needing assistance. In fiscal year 2016, new school clothing and other school essentials were provided to approximately 590 students in the Whittier area.

The Continuing Education program provides scholarship assistance to adult students at Rio Hondo and Whittier Colleges. The colleges identify outstanding students who are single, heads of household. The Chapter's continuing education committee then interviews students identified by the colleges and selects the recipients. In fiscal year 2015, approximately 13 scholarships were provided.
